## Bike Park Rakovac - Terms and Rules of Trail Use

### 1. Acceptance of Terms

By using the trails and facilities of Bike Park Rakovac, you agree to these Terms and Rules of Use. If you do not agree with these terms, please refrain from using the trails and other park facilities.

### 2. Risk Assumption

Mountain biking and similar activities involve certain risks, including but not limited to physical injuries, property damage, and potentially fatal accidents. By participating in activities at Bike Park Rakovac, you voluntarily assume all risks associated with these activities.

### 3. Safety Requirements

- The use of MTB cycling helmets meeting recognized safety standards (e.g., CE, ASTM, or CPSC) is mandatory for all riders.
- The use of protective equipment such as gloves, knee pads, elbow pads, and back protection is recommended.
- Check the condition of your bike and equipment before using the trails.
- Follow all posted signs, trail markings, and instructions from park staff.

### 4. Use of Facilities

- Use the trails at your own risk; they are intended for individuals with an adequate skill level.
- Irresponsible or unsafe behavior, including speeding, performing tricks, or any activity that endangers others, is strictly prohibited.
- The park reserves the right to deny access to individuals who violate these rules.

### 5. Medical Assistance

Bike Park Rakovac does not provide on-site medical personnel. In case of an emergency, immediately contact local medical services. Riders are responsible for their own health insurance and medical expenses.

### 6. Liability Disclaimer

By using Bike Park Rakovac, you release the park, its staff, and associates from any liability, claims, or damages arising from the use of the facilities, including but not limited to acts of negligence, to the fullest extent permitted by law.

### 7. Trail Conditions and Maintenance

Trail conditions may vary due to weather conditions or maintenance activities. Users are responsible for assessing the suitability of trails before riding. The park does not guarantee the availability or condition of trails at any given time.

### 8. Compliance with Laws and Regulations

All users must adhere to applicable local, national, and environmental protection regulations. Non-compliance may result in removal from the park and potential legal consequences.

### 9. Children and Minors

Children under the age of 18 must have written consent from a parent or legal guardian, who assumes full responsibility for the child's safety and adherence to park rules.
